Subject: Education

Keywords: Amalgamations; Consultation; Legitimate expectation; Local management of schools

Summary: Closure and amalgamation of schools; proper procedure; inadequate period of consultation; whether proposals ultra vires

Abstract: Parents have a legitimate expectation tantamount to a legal right to be properly consulted by a local education authority prior to the making of proposals affecting closure and amalgamation of local schools. In July 1983 after proper public consultation, a local education authority made proposals regarding future education in the area. In December after a political change further reports were ordered. A brief consultative document was prepared which contained little information and copies were sent to parents barely three weeks before the deadline for written representations. The authority then made new proposals materially different from the originals. An application was made to quash the decisions as being ultra vires.

Held, granting the application, that (1) the local authority had not acted according to the proper procedural requirements; (2) the parents had a legitimate right to proper consultation which had been met with a wholly inadequate consultative document and an unreasonable time for consultation ([Associated Provincial Picture Houses Ltd v Wednesbury Corp \[1948\] 1 K.B. 223](#) applied; [R. v Liverpool City Council Ex p. Professional Association of Teachers 82 L.G.R. 648](#) followed).
